Even though the world seemed so terrible, Micah didn't give up. He knew that God was a loving, forgiving God. He knew that God was still in control and would make things right.

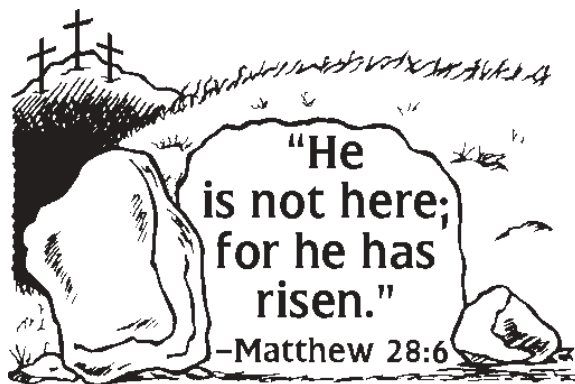

May the peace of our Lord Jesus be with you all. Happy Bless Easter.

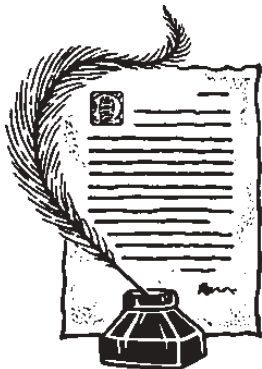

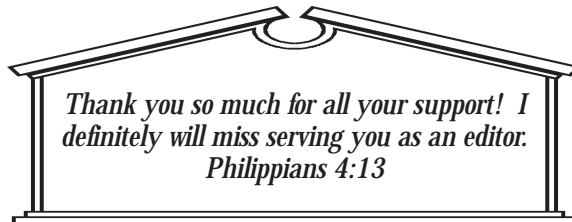


Greetings in the name of our Lord Jesus Christ!

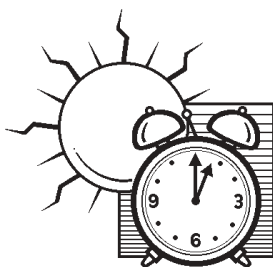

Rev. Donald C. Winkler...

Donald Clifford Winkler was born June 24, 1945. He was confirmed in the Christian Faith in May 1958 in McKeesport, PA. Don graduated from Concordia Preparatory School, Bronxville, NY in 1963. He received an Associate of Arts Degree from Concordia Junior College, Bronxville in 1965 and the Bachelor of Arts Degree from Concordia Senior College, Fort Wayne, IN. Don was married to former Patricia Ann Fulton in January 1969 and their marriage had been blessed with three children. He graduated from Concordia Seminary on May 25, 1972 with the Bachelor of Divinity Degrees. He was ordained into the Holy Ministry on June 18, 1972 at Zion Lutheran Church, Irwin, PA. After a semester of study at Gallaudet College, Washington, DC. He assumed his duties as Pastor of Holy Cross Lutheran Church of the Deaf, Columbus, Ohio where he had served for the past 4 years. In June of that year Pastor Winkler accepted the call of Trinity Lutheran Church of the Deaf, Pittsburgh, PA and he was installed on August 22, 1976, where he had served for the past 6 years. In September 12, 1982 Rev. Don Winkler accepted the call to serve St. Paul Lutheran Church, Sherwood, Oregon where he had served for 12 years. On November 2, 2004, Pastor Don Winkler died at age 59, surviving are his wife, Patricia and five children.

Reverend Bruce Hein...

The Reverend Bruce Hein received his crown of glory January 7, 2005, at home in his wife Cindy's arms.

Bruce was born to Keith and Gail (Mullennax) Hein in Billings, MT on February 6, 1959. In Billings, he was brought to Holy Baptism on February 22, 1959, at Trinity Lutheran Church and confirmed at Mount Olive Lutheran Church on June 10, 1973. When Bruce was four, the family moved to St. Paul, MN. The family returned to Billings where Bruce attended Trinity Lutheran School and he and Cindy first became friends. He then attended Will James Junior High and graduated from Billings West High School in 1977.

Bruce married Cynthia Thompson on July 22, 1978. Their union was blessed with 6 children. Bruce began his college years at MT State Univ., Bozeman, transferring to Concordia, St. Paul, MN, where he earned his B.A. in Education. In 1988, he returned to MT State Univ., Billings, where he earned his B.A. in Computer Engineering. After several years in the computer business he attended Concordia Theological Seminary, Ft. Wayne, IN, where he earned his Master of Divinity in 2000.

Bruce had a diverse background before entering the Seminary. Over a twelve year period, he taught various grade levels, from kindergarten through sophomore in college in all subjects. He also worked construction, served as a ranch hand, had his own computer company, wrote custom software for different industries, and helped establish Montana Communications Network. The church remained a constant throughout his life, where he served in various positions as a layman, including

volunteering to help with the deaf ministry at Mount Olive Lutheran Church. Here he learned sign language and a love for the deaf culture.

Bruce was ordained into the pastoral ministry at Emmaus Lutheran Church, Denver, CO, on June 28, 2000, the 100th ordination anniversary of his great-grandfather, Reverend August Hein. He was called by the Rocky Mountain District, LC-MS, to serve as their Missionary-at-Large to the Deaf from 2000 to 2004. In June, 2004, Bruce accepted a call to Faith Lutheran Church to serve as Missionary to the Deaf in the Front Range. Bruce also served as Assistant Vacancy Pastor to Immanuel Lutheran Church, Colorado Springs, CO. Bruce was diagnosed on August 6, 2004, with Gastro Esophageal Junction Carcinoma, which he fought valiantly for 5 months.

He was preceded in death by his father, Keith; grandparents, August and Freida Hein and Charles Mullennax. He leaves to mourn his death, but rejoice in his eternal life in Christ: his wife, Cindy; children: Kevin Hein; Chandlebray and Brad Hopfensperger; Robert and MonaGayle Book; Marie Hein; Isaac Hein; and Amy Hein; grandchildren: Robert J and Kaitlyn Book; mother, Gail Hein; grandmother, Ava Mullennax; in-laws, Jim and Ramona Thompson; siblings: Gregg and DeAnn Hein; Dwayne Hein; Bethanie Murray; Mike and Mavis Thompson; Geoff and LaRae Talafuse; Don and Jan Thompson; Ron and Sue Going; Darrel and Karen Thompson; nine nephews, eight nieces, and countless brothers and sisters in Christ.

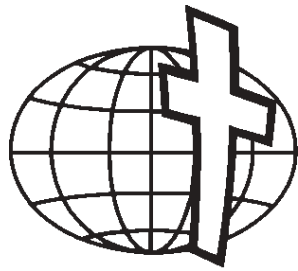

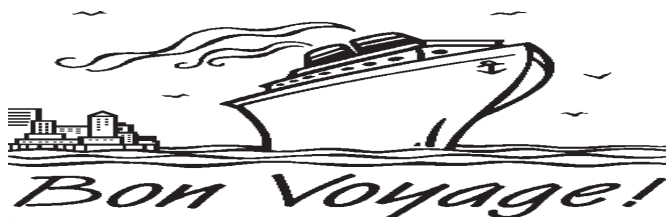

Handbook Proposals for ILDA General Meeting

Article VI REGIONAL PASTORAL ADVISOR

Section B - Responsibilities

New addition: 7. He shall communicate annually with regional president and the congregational representatives via Internet like e-mail or Instant Messaging or Chat Room.

Article IX: Section A - The President:

6. The president may poll the Board of Directors or the Executive Council in writing and/or by e-mail/fax/TTY at any time for directions essential to the operation of the ILDA.

Article IX: Section B - The president-elect:

2. The president-elect's term of office shall be for a period of two (2) years. Change to: **The president-elect's term of office shall be for one term of two years.**

4. The president-elect shall serve as chairman of the Law Committee and act as its representative. Change to: The president-elect shall have two duties:

- 1. Chairman of the Law Committee;**
- 2. Parliamentarian.**

Article XIII: BOARD OF DIRECTORS

Section C - Expenses

1. All expenses incurred in calling and holding a Board of Directors meeting, including the costs of the members' travel, lodging, meals and ground transportation shall be paid by the ILDA.

New addition: a. Board of Directors made of: President, President-elect, Secretary, Treasurer, Pastoral Advisor, representative of the Board for Mission Services, Regional Presidents or their representatives, Deaf Lutheran Editor and Business Manager.

2. Non-Board members, who receive a written invitation from the ILDA president, amend part of a Board meeting will receive one day's lodging and meal expenses paid by the ILDA.

Change to: 2. Non-Board members, who receive a written invitation from the ILDA president amend part of a Board meeting will receive one day's lodging and meals, travel, and ground transportation shall be paid by the ILDA.

New addition: a. Non-Board members are: Immediate Past-President; Committee Chairpersons such as Finance, Law, Mission Project, Nomination, Right Hand Award, Scholarship; past, present and future Convention host chairpersons; ILDA Historian; God's 1000 Club chairperson; etc.

3. Meal expense is limited to \$15 per day per member. (already voted & approved, need to be insert into Handbook.)

Article XIV THE LAW COMMITTEE Section B - Membership

The Law Committee shall consist of the president-elect and two (2) ILDA members from his/her own region nominated by him/her and approved by the president.

The Law Committee shall consist of the president-elect and **two (2) ILDA members from his/her own city/church nominated by him/her and approved by the president.**

Article XVII: GOD'S 1000 CLUB (*revised June 1999)

2. The guidelines are:

1. All ILDA members are encourage to contribute (\$20.00 every two years) (plus dues) and those doing so will automatically receive (biennial) a special membership card, one special lapel pin and be eligible to attend the God's 1,000 Club meetings. Their names will be on a list at the biennial conventions.

Article XIX Past Officer Advisory Council

Section B Responsibilities

4. Training of the new Officers to happen within the period between the approve of new officers and new officers install service at convention.

Article XX: CONVENTIONS (Guidelines for Conducting a Successful Convention)

Section D - Preparing for Conventions

8. The host committee is to submit a full written report (program and financial) to the ILDA Board of Directors six (6) month after the close of a convention. A copy of this report will be kept in a convention planning file and made available to future host convention committees. A copy of this report will be sent to the ILDA historian.

PART II HOST COMMITTEE RESPONSIBILITIES

Article XX

Section D. - Preparing for Convention

1. c. Host Chairman is encourages to request assistant from all of the deaf churches within their region.

Section E - Financing ILDA Conventions

2. The host committee is required to submit a complete financial statement to the ILDA on both pre-convention and convention income and expenditures within six (6) month after the close of a convention. Such reports will be sent to the ILDA secretary and treasurer and made available at the next meeting of the Board of Directors.

Section V. -Parliamentarian

The President-elect shall automatic become the parliamentarian. He/she shall become paralegialbe of both the Constitution and the By Laws.

Article XXI MISSION PROJECTS

Section F - Support of Mission Projects

4. The treasurer will send a report to The Deaf Lutheran editor every two months. Regular articles will encourage support.

Revisions needed to be made to Orange Book

Article V: Section B - Responsibilities:

4. The Regional presidents shall annually meet with the ILDA representative from each deaf congregation and/or field for the purpose of communicating the messages of the ILDA and inspiring support and participation.

1. The Regional presidents shall meet at least annually with the regional pastoral advisor and the congregational representatives at the expense of the regional ILDA.

Change to: **a. The Regional presidents shall communicate annually with the regional pastoral advisor and the congregational representatives via Internet like e-mail or Instant Messaging or Chat Room.**

Article V: Section B - Responsibilities:

15. The regional president shall communicate with the ILDA president each quarter, preferably on March 1st, June 1st, September 1st and December 1st, by letter, e-mail, fax, or TTY.

Article IX: Section A - The President:

6. The president may poll the Board of Directors or the Executive Council in writing and/or by e-mail/fax/TTY at any time for directions essential to the operation of the ILDA.

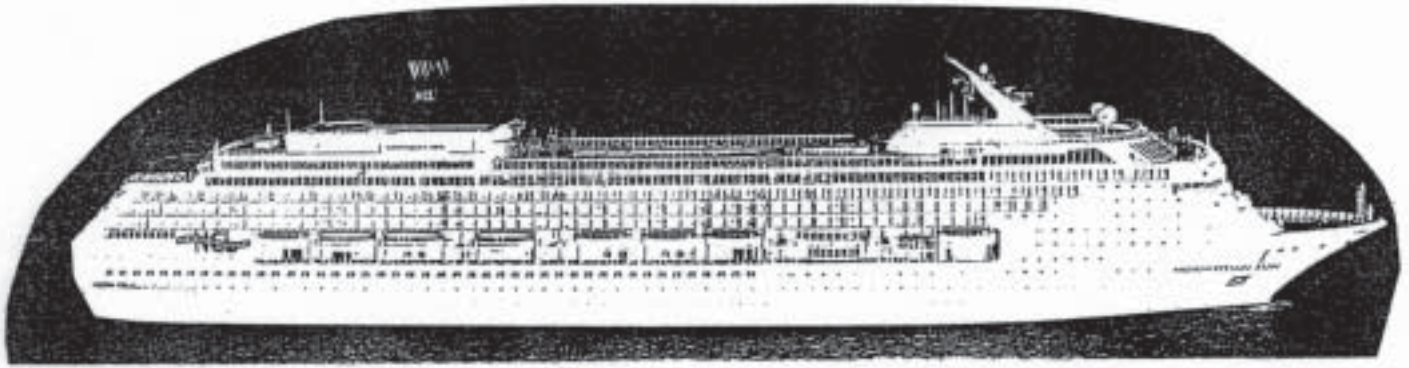
